Job Purpose: The purpose of the position is day to conduct Information (IS) Systems audit as per the approved Annual Audit Plan.

- Preparing Audit programs and Procedures for each Information Systems audit assignment which may include IS network review, Business Applications System Reviews, Data Base Reviews IS security Reviews, IS Process Reviews etc.
- Execute Information Systems (IS) audit assignments and document well referenced working papers for each in accordance with Information Systems Audit and International Professional Practices Framework. (IPPF)
- Perform Information System Reviews to include System development standards, operating procedures, system security programming controls, communication controls, backup and disaster recovery and systems maintenance.
